Northeast KS & Tribes

Tribal Health Fair took place 4/14/22 and it went very well. It was held at the Prairie Band Casino and Resort with 100+ participants, 27 vendors with 58 people representing this group. The casino staff was accommodating. Door prizes offered to participants.

- Seven speakers from the tribes. Topics included: COVID, movement, vaccine equity in the state, and other topics
- Gathering of Native Americans Conference was held to learn about healing yourself in order to help community, historical trauma, interactive workshop, etc.
- Tribes are working with the University of Kansas Medical Center
 COPE team of CHWs on some projects.
- Update for Symposium Olivia had a discussion with a Community Health Representative who is interested in doing an interview for the Symposium. - Articles of incorporation
 - Selected three board of directors.
 - Form 1023-EZ This will need to be signed off by the board of directors.
 - Elaine, Alma, and Carolina will act as the founding board of directors.
 - Did not select official incorporator name and address. Tabled for next meeting.
 - o Reviewed the CHW non-profit start-up checklist.
 - Need to make budget modifications to extend to three years for the Coalition activities. Volunteers needed for this support:
 - Fee for submitting (\$20). Attorney Susan may be able to pay fee if we pay her for that amount.
 - Submit form to IRS to receive Federal Identification Number.
 - Do not need a vote to sign off for the articles of incorporation.

Rewrite mission & vision

- Did not add: certification (we have this paragraph already), sustainability (we have this business case already), resource development (do we have this or want to keep this?)
- Tabled full mission/vision discussion until next Executive committee meeting.

• Fine tune bylaws

- Still need to add parliamentary structure
 - If we decide to use Roberts Rules of Order—determine where we obtain training and set a date to complete)
 - Outline decision making process (tweak current process)
- Carri sends to attorney to review for completeness after final updates are made.
- Need to review discussion questions for founders.
