One crucial piece of this discussion is to add cultural humility/ competence into the curriculum in Spanish. I mentioned how these pieces of education are integrated with the current curriculum. Denise shared how in her county, they are experiencing challenges because interpreters and CHWs are needed to bring this cultural competence to the education provided to Latino families.
