- O The CHW Café was hard to hear the presenters. The presenters were good, but the logistics weren't right. Maybe we need to figure out how to make the presenters more easily heard.
 - Committee feedback:
 - Good information provided
 - Possibly give rooms to presenters
 - More handouts would've provided a solid takeaway from each presenter
 - If presenters could move around a bit, that might have helped all hear
 - Microphone or something (if this would be possible for not to disturb the other presenters)
 - If other people are standing in front of participants it makes it difficult
 - Possibly use the space outside of the doors to spread out speakers
 - Tracks
 - limiting the presentations based on the space...like no more than
 5....4 corners, one center
- The quality of the breakouts is high. Lots of participants wanted to attend all presentations. Consider repeating the same sessions from the morning to the afternoon.
 - Great topics but difficult to choose
 - What is the reason for changing and not repeating the presentations?
 - One option have presenters present during one of the Community of Practice sessions to repeat it during the following year.
 - This happens when you go to other conferences. It is a sign of a good conference.
 - With more breakouts, you get a choice of two
 - I like the repeating to allow for people to participate in more than one
 - Heartland Health Equity Pros: If they are valuable and you want CHWs to have that specific set of skills/knowledge, important to repeat. Always hear participants wanting to repeat. Cons: If you have best-practices you are trying to share, you limit the opportunities that you are trying to share. With more presentations, you offer fresh perspectives. Repeating limits variety of presenters.
 - Explore what the "goals/objectives" are for specific year.
 - Fun to experiment and see what the evaluation is after doing that.
 - Get input from Coalition on what they want to see. (Look at 2023 evaluation.)
- A lot of comments about the appreciation of providing interpretation services. Maybe consider next year offering an entire track in Spanish with several breakout sessions and a portion of the plenary in Spanish.
 - We do have a lot of Spanish-Speaking CHWs and this could be really helpful for them
