- Discussion: Goals for 2024
 - What would we like to work on for the year?

 - CHWs transition out of jobs frequently- how can we address the need for business skills?

 - Many of our school-based CHWs are part of grant-writing teams to find funding for their programs. For many of them--they do not have any experience with grant-writing or finding grants. I think this is a great area for professional development for current CHWs
 - The Palliative care group, they are hoping to educate their clinical providers about how to utilize CHWs in end-of-life care.

- KCHWC has opportunities for scholarships to assist people with taking classes that cost
 - Need to advertise this more as an option
- HRSA Grant writing course is free

- Need for a basic grant writing course that is practical and fits all grants
- Marixendra shared with us last year about CHWs and being asked to be interpreters. Do you know if we need to put this topic on our radar?

• Updates:

- Certification/Recertification Process (Alissa)
 - The certification task force has elected to remove some barriers and make the process more accessible to all CHWs
 - Link: https://kschw.org/certification/
 - Recertification will be launched in February along with a paper version
 - Questions
 - Is there an auto-reminder at the 24-month mark for CHWs to submit their recertification?
 - Yes, Alissa or Katrina will send out the reminder.
 - Is there a timeframe in which they do not submit then they have to go through the certification process again?
 - O If an applicant has not submitted their 20 CE hours report and/or a renewal application, the CHW has a 90-day grace period to submit either document. If the 90-day grace period has passed, the CHW is no longer a Certified CHW in Kansas and will be removed from the Certified Kansas CHW Registry. The CHW must contact cphi@wichita.edu for additional information on reinstating the CHW certification."

- Is there a way that college credits can count toward the CEU?
 - Yes, as long as they apply to CHW work.
- Does someone look over the hours to make sure they count for CEU?
 - o Yes
