• Discussion:

- o Follow up from last month's conversation
 - CHW Career Pathways webinar on Monday, March 18th
 - Grant writing workshops (found in the newsletter
 - CHWs and interpreter roles. What are the differences and boundaries for CHWs in a dual role?
 - What if we were to offer immediate certification upon successful completion of the education course instead of having them apply separately?
 - Could we add milestones for the education cohorts to ensure CHWs are completing their Service Learning (SL) throughout the course instead of waiting until the end? Alissa is piloting that method, and it can be a lot for CHWs. Alissa has pushed to make SL kind of like a "competition" (who can get their SL done first?) Alissa also reaches out to CHWs individually, but some people prefer to wait until the end regardless. In Missouri, some providers require weekly submissions. The course is already very heavy, so

- there is some hesitation to add a weekly work requirement on top of that.
- We give ideas for SL opportunities throughout the course as well.
 We have been working to advocate and partner with supervisors to ensure CHWs in the course have space to complete their assignments in a timely manner.
- When does certification happen?
 - Katrina reviews certification application submissions. Students in the education program currently receive a certificate of completion, which they then use to apply for certification on the education pathway.
 - If we automatically certify CHWs in the education program, we
 may need to rebrand the course as a "certification course" and
 consider the effects on our partners who help facilitate and teach
 the course.
 - All curriculum providers are teaching the same curriculum, which allows us to keep the quality of the course standardized.
 - Keeping the process standardized and ensuring the consistency of all curriculum providers is extremely important especially as we look towards reimbursement for certified CHWs.
